# Legal Services of New Jersey

## Brief Description

---



Legal Services in New Jersey embraces the vision of full access to essential civil legal aid for all economically disadvantaged people who cannot secure a lawyer on their own. This belief in the importance of legal assistance to indigent people stems from an underlying concern with fairness, and a conviction that important legal needs of individuals should be addressed.

The mission of Legal Services, more broadly expressed, is to provide legal representation and advocacy to secure social and economic justice for the disadvantaged and all people.

New Jersey Legal Services' core mission statement is:

*"Just Justice"*

*Legal Services seeks to secure equal substantive and procedural justice for all economically disadvantaged people.*

## VISION

The program must maintain a principal focus on meeting these basic needs. It must strive to pursue actions that have import and sweep beyond the individual parties in specific legal cases. It must prioritize legal representation that will help rebuild impoverished, deteriorating communities, or that address recurrent problems that otherwise would continue to occur in the lives of low-income people.

## Areas of immigration legal assistance

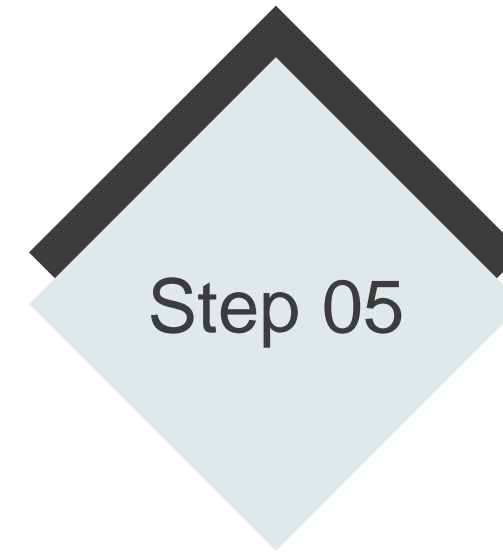
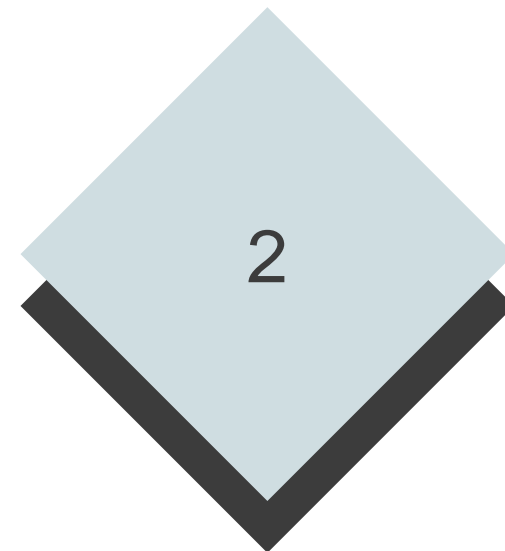
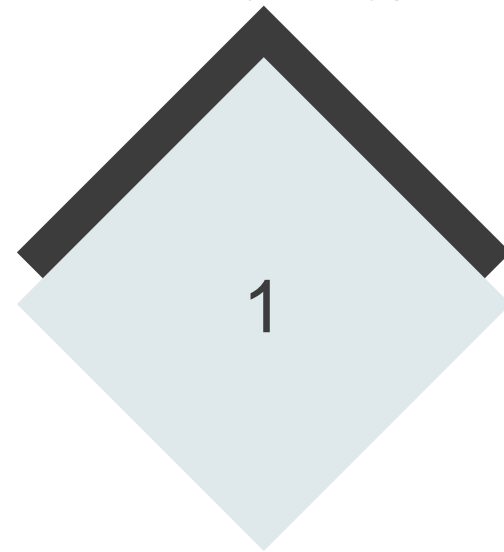
Adjustment of Status, Asylum applications, Deferred Action for Childhood Arrivals (DACA), Employment authorization, Habeas Corpus, , Naturalization/Citizenship, Removal hearings, Special Immigrant Juvenile Status, T visas, Temporary Protected Status (TPS), U visas, Violence Against Women Act (VAWA) petitions

## Other areas of legal assistance:

Consumer, Debt/Credit/Bankruptcy, Disability, Education, Elder Law, Employment, Family & Juvenile, Foreclosure, Homeless, Housing, Prisoners, Public Benefits, Taxes, Veterans

## Populations served

Detained individuals, Domestic Violence Victims, Farm workers, Human Trafficking Survivors, Individuals who are not in legal immigration status, Individuals with criminal histories, Individuals with physical/mental disabilities, Juveniles, Lesbian, gay, bisexual & transgender, Torture survivors



## Types of immigration legal services

**provided:** Filings with USCIS, Representation at Asylum Interviews (Credible Fear Interviews, Reasonable Fear Interviews), Representation before the Immigration Court, Representation before the Board of Immigration Appeals (BIA)

## Non-legal services:

Administrative advocacy (CIS/ICE/CBP), Language services, Legal Orientation Programs (LOP) / Know Your Rights Presentations (KYR), Legislative advocacy (state or national), Referrals to other services, Social services



# PROBLEMATIC

## Poverty & Immigration

Immigration has long supported the growth and dynamism of the U.S. economy. Immigrants and refugees are entrepreneurs, job creators, taxpayers, and consumers.

They add trillions of dollars to the U.S. gross domestic product, or GDP.

Despite the positive impacts of immigrants on the United States' economy and society, the tenor of the new administration threatens to move the United States to a more restrictionist policy environment.

Increased immigration enforcement as well as potential restrictions on legal immigration and refugee resettlement will impose fiscal costs on taxpayers and threaten immigrants, their families, and their communities across the country.

Stepping up detentions and deportations will not only cost taxpayers billions of dollars but will also break apart families and place vulnerable individuals— such as survivors of domestic violence and sexual assault in the United States, as well as women and children fleeing violence in their homelands.

The main objective of our \$1,000,000 donation is to help low income people who cannot afford an attorney or do not have enough resources to resolve immigration problems.

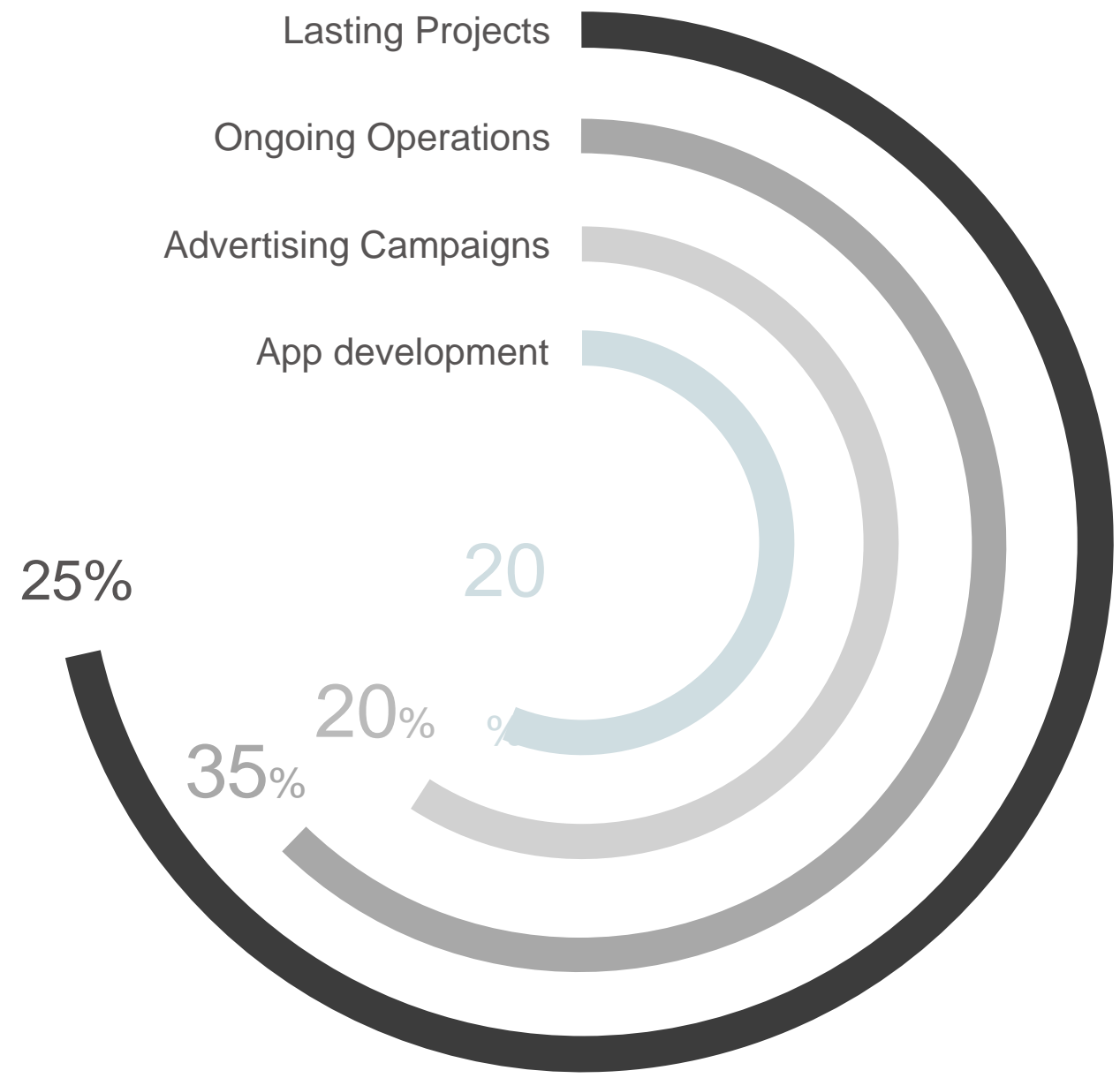
